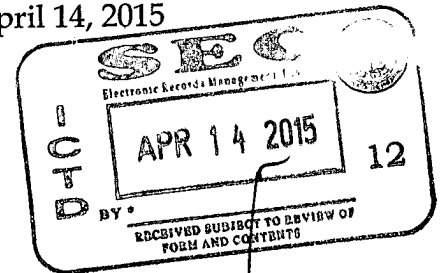



We are pleased to inform you that The Philippine Stock Exchange, Inc.
